 - » Resolution 2024-09-26-01 Adjust Food Fees (Tomcisin): The resolution was introduced by Mrs. Baird. The resolution increases license fees for high and low risk mobiles and temporary food licenses.
 - » Water Pollution Control Loan Fund (Tomcisin):
 - » 6730 Casstown Clark, Casstown: Replacement of septic system with leach lines. Grant pays 100%.
 - » 4320 Myers, Covington: Replacement of septic system with a mound. Grant pays 100%.
 - » Resolution 2024-09-26-02 To Allow Employees to Serve as Precinct Election Officials (PEO) (Propes): Resolution to allow employees to serve as a PEO on the day of an election without loss of their regular compensation for that day per the terms and conditions outlined in the resolution. A motion was made by Mrs. Pittenger and seconded by Mrs. Quillen to approve the resolution as an emergency. A roll call was taken, and the resolution passed.
