6. New Business

- ** Health Insurance Update (Propes): Mr. Propes provided an update on our employee health insurance with the Jefferson Health Plan (JHP) and mentioned we are running a deficit under the current plan. Mr. Propes recommended transitioning to a fully insured model. To do this the agency will have to pay close to \$300,000. This number could fluctuate depending on any run-out claims. Mr. Dugan, our insurance broker, ran numbers with the fully insured model which showed a reduction in costs. Mr. Propes requested the board's approval to move forward by notifying JHP of the intent not to renew with them in 2026. Mr. Ristoff made a motion to notify JHP that we will not be renewing insurance for 2026 and to present any new proposed plan to the board at a future meeting. Mrs. Quillen seconded the motion. All voted in favor.
- » Grant Funding Update (Propes): Mr. Propes reported that the Moms Quit for Two and a Covid grant has been cut. Any additional cuts in grant funding are unknown at this time. Mr. Propes has approved of a change in how we are spending the Workforce

Development Grant and plans to shift more hours in personnel to be paid out of the grant now rather than spreading it out.
