- Whealth Insurance Discussion (Propes): Mr. Propes reviewed the final renewal numbers and presented a history of claim amounts that were paid out over the past five years. Claim amounts being paid out in 2022 were significantly higher than in years past which contributed to the initial 36% renewal. Mr. Propes requested paying the Jefferson Health Plan \$184,000 which would lower the renewal to 15%. Mr. Ristoff made a motion to pay the \$184,000 deficit for a 15% renewal. Mrs. Pittenger seconded the motion. All voted in favor.
- » Divisional Update Community Services (Bednar): Through a PowerPoint presentation, Nate Bednar presented information on the Community Services Division. The presentation focused on programs offered, positions within the division and website/social media updates.
