## HEALTH COMMISSIONER COMMENTS

It is with great pleasure that I present the 2016 Annual Report for Miami County Public Health

This year we maintained our commitment that will lead Miami County Public Health (MCPH) to national accreditation with the Public Health Accreditation Board (PHAB). We have also faced many challenges as a community that MCPH is working to address. Both have made us look at how we are providing services to the community and ways to improve those services.

#### Accreditation:

In 2016 MCPH developed a Quality Improvement Plan, a Workforce Development Plan and a Comprehensive Communication Plan. These plans are all requirements for accreditation and are designed to improve the way we do business. Also, we were able to secure funding from the Ohio Department of Health and The Community Benefits Fund of Upper Valley Medical Center to begin work on our Community Health Assessment; this should be completed mid-year 2017.

Through our pursuit of accreditation, we continued to create a culture of continuous quality improvement throughout the agency. Performance Management was introduced and we have begun tracking the objectives of our Strategic Plan.

As stated in our 5 Core Commitments and our Strategic Plan, customer service is very important to us. We strive to provide exceptional service so that every customer that interacts with us

has a positive experience. Throughout 2016. implemented customer satisfaction surveys in three of our four divisions. The provided survevs have valuable information in regards to the delivery and quality of services provided identifying as well as for opportunities improvements in our services through data collection and analysis.

The Environmental Health (EH) Division of Miami County Public Health (MCPH) serves the community in many ways. We are your health inspectors; your plumbing inspectors and your provider of licenses, permits and registrations for the programs we administer and regulate.

inevitable and Change is we have experienced a fair amount of change in 2016. Starting with the Director, Jeff Koehl, Registered Sanitarian (RS) retired in April 2016 after serving the community for 25 years. Jeff's compassion for people and public health experience will be missed. Jane Tomcisin, RS stepped in to lead Environmental Health, adding 20 years of experience in public and environmental health to the team.

In May, we added an intern with the assistance of a mosquito control grant from the Ohio Environmental Protection Agency. Jonathon Deeter joined us for ten weeks. Jon spent his ten weeks contacting our partners (parks, cities, townships and villages) to request permission to place mosquito traps on public land. Jon prepared and placed mosquito traps, collected the mosquitoes and sent the mosquitoes to the Ohio Department of Health for identification and testing.

In June, Gerry Tipton, RS and Shane Snapp, RS were promoted to Program Managers to help manage the day to day activities with the EH programs.

In August, Janel Hodges RS was promoted to Epidemiologist and Nate Bednar RS was promoted to Emergency Preparedness Coordinator within MCPH. While we celebrated their promotions, we also lost

two experienced sanitarians. Jon Deeter, our intern, was interested in joining us full time as a sanitarian-in-training (SIT) Jon was hired along with Jordan Phillips, also a sanitarian-in-training, to help complete the team.

Not only did EH go through staff changes, we made some significant changes within our programs. The following are some of the changes and highlights from the EH programs.

We began using Healthspace, a database program offered through the Ohio Department of Health to track facilities, invoice for licenses and record inspections for our food, pool and campground programs. Using Healthspace will facilitate our efforts to provide our customers with the ability to view our inspections online through our website. We plan to display inspections on our website by the 2nd quarter of 2017.

In 2016, the Ohio Department of Agriculture completed a Retail Food Establishment program survey and the Ohio Department of Health completed Campground and Pool program surveys. The surveys are conducted on a periodic basis to determine a health department's ability to administer the program. All state survey results approved



MCPH as licensor for the programs.

MCPH successfully submitted an application for assistance to replace or failing household sewage repair treatment systems. A total of \$300,000 was made available to MCPH over a two year period through the Ohio Water Pollution Control Loan Fund administered by the Ohio Environmental Protection Agency. Four projects were completed at the end of 2016 for a total of \$30,655. Multiple projects have been started in Gerry Tipton, RS, presenting information on private 2016 and will continue into 2017 until funding is depleted.

PUBLIC HEALTH NURSING is a specialized area of practice, which strives to preserve the health of populations across the lifespan by emphasizing health promotion and disease prevention and protection.

One area of focus is on Infant Mortality (IM) education. Infant mortality is defined as the death of a baby before his or her first birthday. Ohio's infant mortality rate in 2015 was 7.2 (per 1,000 live births), which is higher than the United States. Miami County's rate is 5.4. Causes of IM include: babies born too small or too early, maternal complications, birth defects, victims of injury such as suffocation from co-sleeping and Sudden Infant Death Syndrome (SIDS).

In an effort to improve Ohio's infant mortality rate, Miami County Public Health is an active member of *The Ohio Collaborative to Prevent Infant Mortality*, with nursing staff participating in the following action groups: *Promoting Optimal Women's Health Before, During and After Pregnancy* and *Reducing Smoking Before, During and After Pregnancy*. MCPH has also provided education to the community on: The ABC's of Safe Sleep, preconception care and the harmful effects of smoking and drug and alcohol abuse.

Nursing collaborated with the Miami County Parks District for the Trail Run Challenges, by obtaining height and weight to determine attendees Body Mass Index (BMI) and providing Blood Pressure screens.

The Nursing Division continues to provide school nursing services to two schools in the county. For 2016 there were 117

vision screens, 105 hearing screens and 35 immunization reviews completed between the two schools.

We will continue collaboration with Dayton Montgomery County Public Health to enhance our HIV Expanded Testing Initiative (162 test completed in 2016).

#### **Vaccines**

MCPH receives vaccines from the state and federal government for all children who are uninsured, on a Medicaid plan or have insurance that does not cover any cost for vaccines.

MCPH also is a recipient of the Immunization Action Plan grant (IAP). The goal of IAP is to get all children in Miami County up to date with

immunizations by the time they are 24 months old. MCPH assesses immunization rates twice a year and identifies strategies to increase rates. The same assessment is available at private physician offices.

Any person traveling out of the US can make an appointment with one of our travel nurses. They will receive counseling on staying safe and healthy while traveling and any vaccines required or recommended for the countries they will visit. In 2016, 166 clients received 358 vaccines for travel.

#### Flu Vaccinations (Seasonal)

In 2016 the Health Department continued to provide flu vaccinations to employees, their families and the community which we proudly serve.

# Affordable Care Act Assistance (ACA)

MCPH has partnered with Health Partners Free Clinic to have an ACA Navigator on site as needed to help clients to navigate their options with the Affordable Care Act. Staff also follow up on clients insurance needs and standing.



This year, Miami County has also seen a significant increase in Acute Hepatitis B and C as well as the sexually transmitted diseases, Chlamydia and Gonorrhea. # Maternal and Child Health (MCH) Programs

**Nutrition and Physical Activity** Program: In an effort to help number reduce the of overweight children in the community MCPH partnered with the Miami County YMCA to bring a nutrition and physical activity program to second grade classrooms at two elementary schools reaching 243 students.

Well Child Clinic: The Miami County Well Child Clinic provides physical exams and immunizations to infants, children and teens from birth thru age 18.

Prenatal Wellness Center: The Prenatal Wellness Center provides full prenatal and postpartum care.

Baby and Me Tobacco Free (BMTF) Program: The BMTF Program is a smoking cessation program for pregnant and postpartum women and their partners. This is a referral based service available to any pregnant woman in Miami County. In 2016 there were 62 individual referrals with 26 enrollees and 99 visits completed.

# **WIC DIVISION**

he Miami County Women, Infants and Children Program continues its commitment to educate participants about healthy eating and to encourage and support breastfeeding in the community. The program participated in various activities and events to accomplish these goals throughout 2016. Hallie Whitley, WIC Breastfeeding Coordinator, applied and received one of ten breastfeeding grants awarded in the state by the Ohio Lactation Consultant Association (OLCA) in 2016. The program received \$400 in grant funds to nurture and support breastfeeding moms and babies in the local community. Some of the monies were utilized to host a "Big Latch On" event at the Troy Community Park on Saturday, August 6, 2016, in celebration of World Breastfeeding Month. This is an international event that provides women an opportunity to gather together and breastfeed as well as to offer peer support to each other. The event was a huge success and was attended by over 65 people including moms, babies and other family members. In addition, some of the OLCA grant funds were used to pay for a booth space at the Miami County Fair so that breastfeeding moms had a more private and

comfortable place available to nurse their infants. The program continues to participate in the Farmers' Market Nutrition Program during the summer and early fall months. Miami County WIC received 155 sets of Farmers' Market coupons with each set containing four \$5.00 coupons for clients to use to purchase locally grown produce at contracted farm stands and markets. participants are provided nutrition education on selecting, storing and preparing fruits and vegetables when coupons are issued. program is beneficial to both farmers and WIC clients by improving awareness and sales at local farm markets while providing participants an opportunity to improve their health by eating more nutritious fresh fruits and vegetables.

The Health Department Tobacco Treatment Specialist started coming to the Piqua WIC clinic once per month starting in June 2016 to counsel and follow up with prenatal clients who expressed an interest in stopping smoking. This is a great partnership and will make a positive impact on improving the health of our pregnant participants.



# VITAL STATISITICS—Birth-Death-Genealogy-Paternity Acknowledgment

The Vital Statistics office files records for deaths that occur in Miami County except for deaths that occur inside the Piqua City limits. Our files date back to December 10, 1908, when the filing system for the state began. Ohio law only allows for the issuance of certified copies of birth and death records. Our office can now issue certified birth certificates for anyone born in the state of Ohio. Any births outside of Ohio must be requested directly from that state. The cost per copy is \$24 and can be requested by mail, telephone order or in person by visiting our office Monday-Friday, from 8-4. We accept cash, check, money order, MC, Visa or Discover.


#### **Current Status:**
