

#### **Well Child Clinic:**

This program offers well child, school, work and sport physicals along with maintenance medication follow up. Services are available for children birth to age 21 years of age who have medical insurance but are unable to find a doctor. MCPH does referrals to Health Partners Free Clinic for children without medical coverage. The Well Child Clinic saw 205 children in 2019. The Miami County Well Child Clinic began in 1978 and was part of the 100<sup>th</sup> Year Celebration of Public Health.

Public Health Nursing strives to offer a variety of health promotion and disease prevention services to the residents of Miami County. We are excited that you have decided to visit us and invite you to explore the different programs that are designed to promote healthy lifestyles and address chronic, acute and communicable diseases. Our primary goal is to provide public health nursing and health promotion services in order to build a healthier community.

#### **Prenatal Wellness Center:**

The Prenatal Wellness Center assists women who are pregnant and unable to see a private OB/GYN provider. MCPH typically sees women who have applied for Medicaid but it is not effective yet. However, recently we have begun seeing women who are self-employed or working but unable to get insurance and they make too much money to qualify for Medicaid. In 2019, the Prenatal Wellness Center had 251 visits. Due to miscarriage, moving, or getting insurance, a portion of our patients are able to transfer to other OB providers. Twenty-seven women continued in our care until they delivered healthy babies. Currently, marijuana use and/or history of drug use has increased among prenatal patients. All women are automatically transitioned into our Reproductive Health and Wellness Program for birth control options after delivering their babies.





#### **Reproductive Health and Wellness**

This program offers birth control options, STD testing, pregnancy testing and basic infertility treatment. MCPH offers services to men and women regardless of their ability to have children or insurance status. We are able to bill insurance. If they have none, we use a sliding-fee scale for services. In the last few years we have seen an increase in women using long-acting reversible contraceptives. Almost 300 visits were conducted and 112 people were assisted with getting on Medicaid/insurance. Often when women do not need refills on birth control, they often forget that they still need a well woman exam for breast and cervical cancer. In 2019, MCPH presented STD education to Newton Junior High, Greenville Med Tech Program, GRADS program and Edison Community College. MCPH has added walk-in hours on Wednesday from 10-11a and 1-2p for women and Thursday from 8-9a to allow greater access to care. We have worked to improve our website and other social media outlets.

#### **Help Me Grow:**

Help Me Grow (HMG) Home Visiting is a voluntary family support program for pregnant women and new parents that strives to cultivate and strengthen nurturing parent-child relationships. Through regular, planned home visits, our trained and credentialed home visitors use a non-judgmental and compassionate approach that empowers parents with skills, tools and confidence to nurture the healthy growth and development of their children. In 2019 our program grew and we hired a new Home Visitor, going from 2 Home Visitors to 3. This additional member of our team will allow us to serve more families in 2020.

#### **Vital Statistics**

The Vital Statistics office files records for deaths that occur in Miami County except for those inside the Piqua City limits. Our files date back to December 10, 1908, when the filing system for the state began. Ohio law only allows for the issuance of certified copies of birth and death records. Our office issues certified birth certificates for anyone born in the state of Ohio. Out of state births must be requested directly from that state. Our certificates are \$24 each and can be requested by mail, telephone order or in person by visiting our office Monday-Friday, from 8-4. We accept cash, check, money order, MC, Visa, Discover and American Express.

#### **Child Fatality Review Board**



#### **Accreditation**

MCPH staff continued working towards public health accreditation throughout 2019. We met our target document submission date of July 25, 2019, over one month before the actual deadline submission date to the Public Health Accreditation Board (PHAB). The agency began its accreditation journey in June of 2014 and by July of 2019, we were able to submit over 300 documents consisting of approximately 10,000 pages to PHAB for review. Throughout 2019, PHAB assigned site visitors reviewed our documentation in preparation for our site visit which will take place in 2020.
