### A MESSAGE FROM THE HEALTH COMMISSIONER

I am pleased to present Miami County Public Health's 2024 Annual Report, highlighting our achievements and impact on the community's health and well-being.

Mission Statement: "The Miami County Public Health team works to prevent illness, promote healthy lifestyles, and protect every person who spends time in our community."

Key Accomplishments:

- Nursing: Focused on preventive care, disease management, and health education. COVID-19, measles, and Tuberculosis were significant concerns in early 2024.
- Community Services: Promoted healthy lifestyles, reduced health disparities, and fostered community engagement through education, outreach programs, and social services. Major projects included the diaper bank and child safety grant.
- Environmental Health: Successfully launched iWorQ software in the Plumbing department, enhanced regulatory compliance and data management efficiency.
- Family & Child Development: The WIC program supported maternal and child health through nutrition education and access to healthy foods. The Help Me Grow program promoted early childhood development and connected families with essential services.
- Administration: Supported operations including budgeting, human resources, public health accreditation, strategic planning, policy development, IT, and vital records.

<u>Looking Forward:</u> We will focus on succession planning and reaccreditation, while continuing to adapt, innovate, and collaborate to meet the evolving needs of our community.

<u>Gratitude:</u> Thank you to our dedicated staff, Board of Health, partners, and stakeholders for their support and commitment. Together, we will continue to build a healthier and more resilient Miami County.

Dennis R, Propes, REHS, MPA Health Commissioner Miami County Public Health The Board of Health is a combined board of health representing the merger of the General Health District, the Tipp City Health District, the Piqua City Health District, and the Troy City Health District. The General Health District includes all townships and villages in the county. In an agreement for merger, the original Board of Health of the General Health District was expanded to include representation from Troy, Tipp City, and Piqua.

The District Advisory Council is made up of the chair of each township's trustees, the chief executive officer of each village and the president of the Board of County Commissioners. They appoint four members of the Board of Health.

The Mayor of Tipp City appoints one member from Tipp City. The Mayor of Troy appoints two members from the City of Troy. The Piqua City Council appoints one member from Piqua.



# **Public Health Accreditation**

In 2024, MCPH has been tirelessly working on reaccreditation. MCPH contracted with Kent State University to complete the 2024 Miami County Community Health Assessment (CHA) which will be used to direct efforts in the 2025 Community Health Improvement Plan. The assessment is used not only by MCPH but also by partner agencies in the county.

Monthly meetings are being held with reaccreditation domain leads preparing for MCPH's fast approaching reaccreditation deadline. Monthly internal reaccreditation workgroup hours are held for staff to focus on reaccreditation materials.



### Reproductive Health and Wellness (RHW) & Preconception Wellness (PW)

- Services: STD/cervical cancer screenings, pregnancy testing, planning, birth control counseling.
- 2024: 4 screening events, 4 educational sessions.

### Children with Medical Handicaps Program (CMH)

- Serves children with special healthcare needs.
- 2024: Nurse Case Manager had 1,076 family contacts, served 577 families in Miami County.

### Maternal Child Health Program (Well Child and Prenatal Wellness)

- United Way Agency.
- Well Child Clinic: Medical care for children with no other options.
- Prenatal Wellness Center: Safety net for pregnant women facing barriers.
- Growing demand due to OB provider shortage and hospital OB unit closure.

### Lead Poisoning Prevention

- Received grant for awareness.
- Provided info to physician offices, agencies, daycares, preschools.
- Billboards in high-risk areas.

### School Nursing

• 176 vision and hearing screenings at 2 schools in Miami County.

### Immunizations/Get Vaccinated Ohio

- Our immunization clinic serves all ages
- Educated healthcare providers on immunizations
- Completed a 12-month quality improvement project for MCPH
- Conducted immunization assessments for 6 schools
- Provided 7 school nurse education sessions



Thanks to grant funding from the UVMC Community Benefits Fund the Nursing department was able to purchase some much-needed items for our clinics. A few of these items include a new exam table, a portable electronic blood pressure monitor, an autoclave machine, laptops for our staff, and other items to ensure our clinics continue to run effectively. They also continue to help financially support our Nurse Practitioner positions and in 2025 we are planning to expand these hours.




In June, Dr. Burkhardt retired as Medical Director for Miami County Public Health after 25 years. Dr. Penny Hogan took over as Medical Director in July.

# **Environmental Health**

### Highlights from 2024...

#### **Rabies Monitoring**

Environmental Health educates on disease prevention. While rare, human rabies is nearly 100% fatal without quick treatment. A 2024 death in Northern Kentucky underscores this urgency. In Ohio, bats and raccoons commonly carry rabies. Vaccinating pets is essential. In 2022, a rabid bat bit a resident, who received lifesaving treatment. In 2024, there were nine bat exposures in Miami County, three tested negative. Ohio reported 43 rabid bats and one raccoon in 2024. More info: Rabies Monitoring

#### Plumbing Inspections

Environmental Health's Plumbing Division reviews and inspects plumbing work in Miami County. Darke, Shelby, Auglaize, and Mercer counties also contract for these services. Plumbing in Mercer and Auglaize is limited to commercial facilities. Champaign and Clark counties use backup services. Miami County has a Chief Plumbing Inspector and two Inspectors covering these counties.

#### Mosquito Surveillance

With an Ohio EPA grant, we conducted mosquito surveillance through a summer intern. Traps were set, and mosquitoes were sorted by species and gender. The Ohio Department of Health (ODH) tested 572 mosquitoes for West Nile Virus; none were positive.

#### Household Sewage

Ohio EPA funding enabled the replacement or repair of nine failing sewage systems at low or no cost to eligible Miami County households.

#### **PIC Certification**

Starting November 2023, Miami County Public Health offers the Person-In-Charge (PIC) Certification in Food Protection. Ohio food code requires one PIC in a food facility during operating hours. Environmental Health Specialists teach this three-hour course. Since November 2023, 102 people have completed it.

## **Children and Families**

### Women, Infants and Children (WIC)

- Miami County WIC partnered with MCPH Health Educator to distribute \$30 WIC Farmers' Market vouchers at the Piqua and Cherry Street Farmers' Markets, issuing 100 sets of coupons to women and children. Families received education on selecting, storing, and preparing fresh produce.
- In 2024, WIC began using the State-provided One Call Now (OCN) system for appointment reminders and notifications, reducing postage costs.
- Breastfeeding Peer Helper Antoinette Gibson launched the combined Shelby & Miami County Breastfeeding Mamas Group on Facebook for communication, education, and support.
- WIC celebrated its 50th anniversary in 2024 during National Nutrition Month with the theme "Celebrating 50 Years of Keeping WIC Families Healthy." State WIC provided local projects with small plastic cutting boards, cookie cutters, and a tip sheet for making healthy food fun, including QR codes for activities and recipes using WIC-provided foods.

### Help Me Grow (HMG)

- HMG completed the accreditation process with Healthy Families America
- HMG collaborated with other MCPH departments to host the Back to School Clothing Give Away for the county
- HMG Supervisor/Program Manager became a certified child passenger safety technician. This certification allows her to install car seats for people in the community, educate them about proper installation, and complete checks to make sure that families have properly installed their own car seats.
- HMG Attended multiple outreach events throughout Miami County

### Community Services Program Highlights

- Community services staff applied for continuation of Tobacco Use and Cessation grant and Project DAWN Contract. These grant funds are a big part of our community outreach activities.
- In 2024 we received money from The Troy Foundation to continue operating the diaper bank. Each participant is aged 0-3 years, must live in Miami County, and be financially eligible for WIC. It is not a requirement to be enrolled in WIC. The diaper bank provides 50 children with 100 diapers and 300 wipes each month. It operates on a first-come, first-served basis one Friday per month. The diaper bank also serves as a way for parents to get connected with other MCPH programs and local resources. For children over age 3 with a documented medical diagnosis prolonging potty training, the social worker will work to connect them with a long-term resource for diapers or pull-ups.
- Community services continued our successful outreach program by working with Bethany Center in Piqua and Health Partners in Troy and other partners to distribute resources such as Narcan, smoking cessation, vaccinations, WIC card loading and many other services.
- The car seat program at Miami County Public Health provides education and training on proper car seat use, performs car seat checks by one of four certified technicians, distributes car seats to eligible families, and engages in community outreach to promote child passenger safety. The car seats are funded by the Ohio Buckles Buckeyes program and the Miami County Foundation for infant car seats.
- COVID test giveaways continue to be popular to the community. MCPH receives test kts from ODH and provides them free of charge at MCPH service counters.







The Board's purpose is to reduce the incidence of preventable child deaths. The Board reviews those deaths that could have been prevented and identifies strategies to help prevent future deaths.
