Public Notice of Hearing for Proposed 2024 Miami County Public Health Food Service Operation and Retail Food Establishment License Fee Adjustments

On September 28, 2023, the Miami County Board of Health conducted the first of three readings to establish Food Service Operation and Retail Food Establishment license fees for the 2024 licensing year. In accordance with the Ohio Revised Code chapter 3717, the local licensor shall give written notice to all establishments that may be affected by the change in fees.

The proposed license fees for Miami County Public Health Food Service Operations, Retail Food Establishments, Mobile Units, Vending Machines and Temporary licenses for the 2024 licensing year are as follows:

Local Fee	Local + State Fee*
Level 1 < 25,000 sq. ft. increase from \$167.00 to \$192.00	\$ 192.00 + 28.00* = \$220.00
Level 2 < 25,000 sq. ft. increase from \$187.00 to \$215.00	\$ 215.00 + 28.00* = \$243.00
Level 3 < 25,000 sq. ft. increase from \$362.00 to \$416.00	\$ 416.00 + 28.00* = \$444.00
Level 4 < 25,000 sq. ft. increase from \$459.00 to \$528.00	\$ 528.00 + 28.00* = \$556.00
Level 1 > 25,000 sq. ft. increase from \$242.00 to \$278.00	\$ 278.00 + 28.00* = \$306.00
Level 2 > 25,000 sq. ft. increase from \$254.00 to \$292.00	\$ 292.00 + 28.00* = \$320.00
Level 3 > 25,000 sq. ft. increase from \$910.00 to \$1,047.00	\$ 1,047.00 + 28.00* = \$1,075.00
Level 4 > 25,000 sq. ft. increase from \$965.00 to \$1,110.00	\$ 1,110.00 + 28.00* = \$1,138.00
Mobiles – No increase	\$ 130.00 + 28.00* = \$158.00
Vending – No increase	\$ 22.00 + 6.00* = \$28.00
Temporary – No increase	\$25.00 (no state fee)

The increase in fees shown above is from the 2023 license fee.
