

# PLUMBING PERMIT APPLICATION

Anyone doing plumbing work in Miami County is required to apply for a Plumbing Permit with the Miami County Public Health.

### **COMMERCIAL REQUIREMENTS:**

- \*Commercial plumbing must submit isometric drawing along with a complete, signed application.
- \*Plans must be approved by inspector before permit is issued.
- \*Plumbing Department has 30 days to review drawings.
- \*Commercial Registered Plumbing Contractor must meet with plumbing inspector 8 9am or by appt.
- \*Commercial Plumbing Contractor must have Ohio State License

If a food service is involved, the Environmental Health Department must receive a set of drawings and the plans must be approved by a Food Service Sanitarian before a plumbing permit will be issued.

## **RESIDENTIAL – SEWER & WATER, WATER SOFTENER & WATER HEATER REQUIREMENTS:**

- \*Registered Miami County Plumber submits completed form
- \*Permit applications may be faxed with credit card information to 937-573-3502

### **HOMEOWNER REQUIREMENTS:**

- \*Homeowner must be doing the plumbing
- \*Submit Isometric drawing and meet with Plumbing Inspector 8 9am or by appt.
- \*Must live in the house for 1 year after final inspection.
- \*Landlord/Owner of rental property MAY NOT complete plumbing work.
