Public Notice of Hearing for Proposed 2024 Miami County Public Health Swimming Pool/Spa/Special Use Pool Fee Adjustments

On September 28, 2023, the Miami County Board of Health conducted the first of three hearings to establish Public Swimming Pool/Spa/Special Use Pool license fees for the 2024 licensing year. In accordance with the Ohio Revised Code chapter 3749, the local licensor shall give written notice to all establishments that may be affected by the change in fees.

The hearing will be held during a scheduled monthly Board of Health meeting:

The proposed local fee adjustment will become effective January 1, 2024. The state fee remains unchanged:
