Public Notice of Hearing for Proposed 2026 Miami County Public Health Food Service Operation and Retail Food Establishment License Fee Adjustments

On September 25, 2025, the Miami County Board of Health conducted the first of three readings to establish Food Service Operation and Retail Food Establishment license fees for the 2026 licensing year. In accordance with the Ohio Revised Code chapter 3717, the local licensor shall give written notice to all establishments that may be affected by the change in fees.

The proposed license fees for Miami County Public Health Food Service Operations and Retail Food Establishments for the 2026 licensing year are as follows:
